SOL SCHEPPS

As a practicing lawyer for 32 years, Sol routinely handles a heavy caseload, having tried countless cases from simple one-witness judge trials to long-term complex jury trials. He began his career with The Legal Aid Society in the Bronx, partly with the Special Litigation Unit. Now a sole practitioner focusing on criminal works, he has briefed cases and argued before our State's Appellate Courts and Federal Court. He has a wealth of experience with traffic, landlord-tenant, real estate, contracts, immigration and torts.

Sol knows the law. He's in court almost every day - from city to local courts. He knows the courtroom and how to run it. His business is, in large part, to know people. A good judge needs this skill.

Sol is clear:

"The Courts are there to serve and protect the people and the community. Party affiliation is not significant - the job of judging is emphatically not political. A judge can't be afraid to follow the law, regardless of party. That's my commitment."

Sol has lived in North Salem since 1989. He and his wife Karen raised their family here. He is currently on the Town Housing Board and is a past volunteer with the Croton Falls Fire Department. He was president of the Lake Hawthorne HOA and for years he coached kids in youth soccer, hockey and little league baseball. He has mentored several students in the Options program at North Salem High and has judged Options presentations, as well as the Columbia University Undergraduate Mock Trial Program.
